#### The five Master Entrepreneurs include...



Kate Carnell AO beyondblue, CEO

Ms Carnell became the first Liberal woman to be elected as Chief Minister or Premier in Australia when she became Chief Minister of the ACT in 1995. Before that, she was a small business operator and pharmacist and the first woman National Vice-President of the Pharmacy Guild of Australia. Ms Carnell has been a beyondblue Director since 2008 and Deputy Chair since 2010. Beyondblue address issues associated with depression, anxiety and related disorders.



Bill Mobbs
ITL Limited, CEO

Bill, a lifelong entrepreneur and a pioneer in the protection of healthcare workers, founded the \$40 million medical devices company, ITL Limited. Bill has a family of between 10 and 15 patents and created a company that employs 380 people in Malaysia, Australia, the US and Europe. One of Bill's early successes was DonorCare®, a needle guard designed to reduce the risk of needlestick injuries to healthcare workers, donors, hospital staff, and others.



Ralph Wilson Willow, CEO

You are likely to have more than one Willow product in your home. Mr Wilson is CEO of the fourthgeneration manufacturing business that produces household items ranging from laundry baskets and buckets to plastic coolers, bakeware and water bottles. Willow is stocked at all major retail outlets, ranging from Kmart and Bunnings to Coles and Woolworths. Mr Wilson is an Adjunct Professor at Bond University when he is visiting speaker on family business and business innovation. He is also actively and prolifically involved in not-for-profit organisations.

Geoff has extensive experience as an executive coach, mentor and strategy advisor. He draws on more than 30 years in both the IT and infrastructure sectors.
